Section 10 - Stability and Reactivity		

Reactivity: Reacts with zinc to form explosive hydrogen gas. Catalyses exothermic polymerisation of vinyl ether. Explodes at room temperature when added to furan-2-percarboxylic acid. Dissolution in water is exothermic. **Conditions to Avoid:** This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry. Keep containers and surrounding areas well ventilated. **Incompatibilities:** water, boric acid, calcium oxide, bromine trifluoride, zinc, vinyl ether, furan-2-percarboxylic acid. **Fire Decomposition:** May form hydrogen chloride gas, other compounds of chlorine. Calcium compounds. **Polymerisation:** This product will not undergo polymerisation reactions. However, it acts as a catalyst for the polymerisation of vinyl ether.

Section 11 - Toxicological Information

Potential Health Effects

Inhalation:

Short Term Exposure: Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

Long Term Exposure: Long term inhalation of high amounts of any nuisance dust may overload lung clearance mechanism. No data for health effects associated with long term inhalation.
